FPT Spring international internship program 2023 [business] Application Guide for the Business Internship Program Co-sponsored by FPT University

Hosei University will host a business internship program, lasting for about four weeks, at a number of companies in Vietnam in cooperation with FPT University, which is our partner university established with the aim of cultivation of human resources by FPT Corporation, the largest information technology (IT) company in the country. Under the program, students can experience an internship not only in IT fields such as software development, but also in various other business fields, including personnel affairs, marketing, publicity and quality assurance.

Note: You can't apply more than one program in the spring of 2023

Objective: To acquire business skills at a global level through internships at Vietnamese companies.

Co-sponsor: FPT University (in Vietnam) http://international.fpt.edu.vn/

Number of participants: 4 persons

*If none of the applicants is suited for a certain destination, participation in the program at the destination may be cancelled.

Eligible applicants: University students and graduate students

* Any major is OK, but the available positions and companies of the internship are mainly in IT & Business.

Internship site: Vietnam Danang *Work location depends on the place of each internship-hosting company.

Application for Credit: Credit can be applied for but credit granting policies may differ between faculties.

Training contents:

Selected applicants will take part in training sessions to acquire basic knowledge including Vietnamese culture and business manners at Vietnamese companies, and then will be sent to different hosting companies to do an internship for about four weeks. After the selection of applicants, they will be assigned to suitable hosting companies depending on the category of business and type of work desired by each participant - encompassing a broad range of business fields, including IT fields such as software development as well as personnel affairs, marketing, publicity, and quality assurance - through in-person and online meetings and other modes of correspondences among Hosei FPT University and hosting companies in Vietnam.

Qualification: Applicants must satisfy all the following requirements:

- 1. Communication skills in English or the local language of the destination (No minimum score standard) **Communication skills in the local language of the location is preferred.
- 2. Applicants must be able to <u>participate in all</u> of the explanatory meetings and review seminars designated by Hosei University and FPT University before and after the internship program.
- 3. Consent of a guarantor for the application/participation
- 4. Passport must be valid for at least 6 months from Feb. 24. *New or updated passports must be obtained by Oct. 21 (Sat.).

Note: Be sure to confirm the content of this document before application.

- (1) Participants are not allowed to visit countries other than the destination on the way to or back from the program.
- (2) Participants must purchase air tickets designated by the university for the purpose of risk control.
- (3) Participants must take out overseas travel insurance designated by the university.
- (4) In case of cancellation, you will be charged with an amount equivalent to the actual costs claimed by the co-host (FPT) at that point.
- (5) Participants must sign a pledge before departure.
- (6) Participants must submit a report in a predetermined manner.
- (7) Read the Ministry of Foreign Affairs' safety information concerning security of your destination and the precaution statement of the Ministry of Health, Labor and Welfare quarantine station for infections and other health hazards.
- (8) Participation in the program may be terminated if a participant engages in any act that is illegal or offensive to public order and morals.
